## **Important Safeguards**


#### **Required tools**

- Phillips screwdriver
- Drill with appropriate bit for pre-drilling wall anchor holes

**CAUTION** Installation and servicing should be performed only by qualified and experienced technicians to conform to all local codes and to maintain your warranty.

## Removing the Camera from the Base

Loosen the locking screw on the camera enclosure to remove the enclosure from the camera base. Set the camera body aside.



#### **Preparing the Mounting Surface**

- 1. Place the mounting template where you want to install the camera.
- Drill four (4) holes in the mounting surface for the wall anchors, then insert the wall anchors.
- Drill an appropriately sized hole and pull the cables through the mounting surface.

## **Mounting the Camera**

- Route the cables through the camera base.
- Align the screw holes on the camera base with the plastic wall anchors.
- Attach the camera base to the mounting surface using the supplied screws.

#### **Installing and Adjusting the Camera**

- Connect the Ethernet cable to the RJ-45 port on the camera.
- If the other end of the Ethernet cable is NOT connected to a PoE switch or NVR. connect the power connector of the camera to a 12 VDC power source.
- Reattach the enclosure to the base and tighten the locking screw.
- Rotate the camera body to the desired position.

## **Logging On to the Camera**

If the camera is connected to the PoE port of a Honeywell Embedded NVR, you can log on to the camera directly from the NVR.

To log on to the camera from a PC:

(North America only)

- 1. Install the Honeywell Config Tool from the installation CD.
- Use the Config Tool to discover the camera and open the camera's webpage.
- Log on to the camera as the admin user. The default user name is admin (casesensitive) and the default password is 1234.
